Subject: Clarification regarding new Comprehensive guidelines of PM KUSUM -reg.

In continuation of this Ministry's Office Memorandum of even number dated 17.01.2024 regarding comprehensive guidelines for implementation of PM-KUSUM Scheme, and Ministry's OM dated 29.01.2024, it clarified that prevailing CFA under this component would be valid till any update is announced by MNRE.


2. In view of the representation received from SIAs it is again clarified that

a) CFA of Rs 1.05 Cr/MW would be valid for all those LoAs, till any further update is announced by MNRE.

b) The DCR exemption would be valid for all those **Letter of Awards** which have been issued on or before 31.03.2024.

3. All the SIA's are requested to make a note of the above clarification and are requested to expediate the implementation of PM KUSUM Scheme. Further the progress made under each of the PM KUSUM scheme components shall be submitted, duly signed, to this Ministry on a monthly basis (Formats enclosed)
